436. WELCOME FROM THE MAYOR

The Mayor welcomed everyone and opened the meeting. He reminded members of the importance of the Civility & Respect Pledge and reminded members to be kind and considerate of their conduct during the meeting.

Members were informed that as per Standing Order 12 – Rules of Debate, speeches were limited to 3 minutes, and thanked members for their co-operation with this.

439. MOTION TO COUNCIL

The Mayor advised that in accordance with Standing Order number 8, the following motion had been submitted to the Clerk by Councillors A Hall and M Ryan, that:

- A) That Newton Abbot Town Council do debate the proposals by Devon County Council and Teignbridge District Council for ‘enhancements’ to Queen Street, Newton Abbot in relation to concerns raised by the businesses situated in the area, the loss of car parking and in particular disabled parking; and
- B) That Newton Abbot Town Council should consider making very strong representations to the County and District Councils for the scheme to be abandoned in the light of the many concerns expressed by businesses and users of Queen Street.’

The Mayor invited Councillor Ryan to read the motion to the council, after which the Mayor invited members to debate the proposals by Devon County Council and Teignbridge District Council for ‘enhancements’ to Queen Street, Newton Abbot.
