INFORMATION FOR CANDIDATES

A vacancy has arisen for one Councillor in the Bushell ward of Newton Abbot Town Council. As the requisite number of requests to fill the vacancy by election has been received, an election will be held on Thursday 8 February 2024.

As a Town Councillor you will become a voice for your community and can make real change by investing time in local projects and issues to the benefit of residents and the neighbourhood. Councillor responsibilities fall into three main categories:

- Decision making: by attending meetings/committees.
- Monitoring: ensuring decisions lead to efficient & effective services
- Getting involved locally: as local representatives Councillors have responsibility towards their constituents and local organisations.

What skills do I need to be a Councillor?

As a Town Councillor you need to be able to:

- Listen
- Act as an ambassador for your community
- Attend Council meetings
- Abide by the Seven Nolan Principles of Public Life:
 - ♦ Selflessness
 - ♦ Integrity
 - ◊ Objectivity
 - Accountability
 - ◊ Openness
 - ♦ Honesty
 - ♦ Leadership

Can I stand tor Election?

To stand for election to a local council you must be:

- A UK or Commonwealth citizen; or be a citizen of the Republic of Ireland; or be a citizen of another Member State of the European Union
- At least 18 years old
- An elector of the local council; or in the past 12 months occupied land or other premises in the area the local council serves (as owner or tenant); or work in the area local council serves (as your principal or only place of work); or live within three miles of the local council boundary.

Will I receive Training and Support?

Being a councillor is a varied and highly fulfilling role. You don't need any experience or special qualifications, and you'll gain lots of new skills, experience, knowledge, and confidence. You will receive training and support through National Associations.

What is the commitment?

You have a duty to attend a minimum of 6 Council meetings per year but depending on how many committees you join, will depend on the level of commitment. NALC's Local Councillor Census Survey found that councillors put aside, on average, three hours a week for council work. Council work often includes attending meetings, engaging with residents and speaking to local groups and bodies as a representative of the council.
